Specifications:

1. Obtain a demolition permit from the Department of Development. Please note that permits are for limited time frames and work must be completed within them.
2. Obtain a right-of-way permit from the Department of Public Works and follow the requirements of both departments.
3. Contractor is responsible for all utility(s) location and proper notification.
4. All buildings and structures (primary dwelling, garages, sheds, etc.) on the properties **MUST** be demolished and all related junk and debris removed. Contractor has ALL salvage rights to structural steel on site that must be separated and not included as C&D waste that is to be transported to the Chautauqua County Landfill.
5. Remove or bury ALL foundation material to a minimum depth of two feet below grade, remove concrete steps, walks, slabs, asphalt and old foundations, **AND RETAINING WALLS** and fill all voids with compacted screened gravel.
6. Remove ALL trees and stumps, shrubs and bushes. Re-seed with perennial grass seed (10 pounds/5,000 sq. ft.), provide a minimum of two (2") inches of top soil and ground cover (i.e. straw or peat moss).
7. This project is being paid through public funds and is therefore subject to prevailing rate. NYSDOL PRC#: [2019010399](#) & [2019014449](#)
8. Liability: The contractor shall be held responsible for negligence, broken sidewalks blocks, approach concrete as a result of the work. Costs shall be determined by the Department of Public Works. The contractor is expected to carry out all work in a timely manner per a signed agreement with the Department of Development once a bidder has been chosen.
